The proposed work is in building 107. As part of a fan coil replacement project, existing supply air duct and wall-mounted supply air grilles are to be removed at six locations. The existing walls are 16"x8"x8" CMU. Four of the locations are above the ceiling in Training Room A162. The wall patching at these locations will not be visible to room occupants once construction is complete.

The other two locations that require wall patching are located in Storage Rooms A165 and A166 and will be visible to room occupants.

The proposed wall patching method is to cover the six openings with sheet metal painted to match the wall. If desired, the openings can be in-filled with new CMU and painted to match at the two visible or at all locations (please advise). See attached photos and floor plan sketch. Locations circled in green are visible and those circled in yellow are not visible to building occupants.
