Phase -2 Remodel the existing conference room to facilitate a new kitchen for the cadet's use. This phase will involve installing new kitchen cabinets and appliances, as well as, new electrical outlets and connections including lighting modifications. In addition, a new residential kitchen stove exhaust vent will be installed and exhausted through the roof. New water supply will be provided for the new sink, dishwasher and the reused and relocated existing refrigerators. The room will be repainted and new vinyl tile flooring will be added under the Phase -1 scope of work.
