Please see our list of priorities below:

- 1. Installation of ADA Ramp \$17,000
- 2. Ceiling and Floor Insulation \$33,000
- 3. Sound System with Acoustical Panels \$51,150
- 4. Replace backdoor and frame \$9,240

Thank you for your attendance and patience through the grant review hearing. The Commission's award hearing will be rescheduled as soon as possible to complete the award process for the 2023-2024 grant cycle.

To the Nevada Commission for Cultural Centers and Historic Preservation...

Please considering awarding the Town of Genoa \$110,390 of the \$6.6 million available for the 2023-2024 grant cycle. For your viewing, please see a brief history with additional information regarding our request for funds.

### **About Genoa**

- The Town of Genoa is considered Nevada's oldest settlement. Genoa has stood the test of time surviving deep winter snows, mud slides, fires, floods and abandonment. Today, the little historic town of 250 residents is a proud symbol of the pioneers who, with vision and determination, could and did carve out a better way of life in the Wild West.
- Genoa's original church was built in 1857, but sadly burned down in the fire of 1910. However, soon after the
  fire, the church was rebuilt at its current location. Our <u>town hall</u> was built in 1886. Both buildings remain in
  good condition and are a main source of our facility rental revenue today.
- Genoa has 153 lots within town. The annual Candy Dance is the main source of revenue for Genoa and in a
  good year is about \$175,000 with Intergovernmental Taxes being our second largest source of revenue
  (<85,000) and facility rentals being our third (\$33.000+/-). Genoa survives on a very small annual budget. Every
  dollar saves counts immensely.</li>
- The Town of Genoa generates enough yearly income from the facility rentals, that with the assistance of volunteers, is able to maintain these buildings in 'good condition'. However, it does not allow the town any extra funds to make improvements. In today's rental economy, renters are looking for benefits such as built in sound systems with clear good quality acoustics. Our Town Hall has terrible acoustics due to the extremely high rounded ceiling. Even with a microphone connected to speakers, the majority of the audience is unable to hear all of the words being spoken. Our Genoa Town Advisory Board meetings are a perfect example of the inability to hear. After each meeting, I receive complaints from members of the audience about the acoustics. I have attempted multiple configurations for set up and nothing has helped.
- Genoa is supported by the Non-Profit Organization 'Friends of Genoa'. This organization raises money for projects within the town, as well as, assists to recruit volunteers to help with various projects within the town. Some examples of these projects would be the Lillian Virgin Finnegan Statue, the Kiosks (North and South end of town), the Welcome to Genoa Signs (North and South end of town), financial assistance with the recent church foundation projects, as well as the exterior painting project. In addition, Douglas County will support this project by providing administrative labor and support to help ensure the project is completed under budget and on time.

#### **Town Hall**

- The Town of Genoa's utility costs run approximately \$1,700+ for gas and electricity for the Town Hall during winter months due to lack of insulation. The building has no insulation. By insulating the ceilings and floor, we would expect those costs to decrease immensely even though there will be no insulation in the walls.
- An ADA Ramp is a very important improvement that needs to take place soon. We do have 3 exterior doors in the building, 2 exits require the use of stairs, leaving the front entrance the only entrance from ground level.
- The Genoa Town Hall brings people of all ages together. Whether it be one of our many town sponsored events such as our free to the public St Patrick's Day Celebration, or our annual \$5.00 Breakfast with Santa that sells out every year, or our annual Genoa Country Christmas Concerts. Or, one of the many rentals such as weddings, memorials, wedding/baby showers or monumental birthdays and anniversaries. The Genoa Town Hall always has been and always will be place bringing people together making memories for a lifetime for many generations.
- Not only does the Genoa Town Hall serve as a meeting place for locals, many of our renters are from outside the area and choose Genoa as a central location for guests who will be traveling from outside Douglas County. Genoa is definitely a 'destination' town.

- In addition to public rentals, the Town Hall is used for monthly Genoa Town Advisory Board meetings, neighborhood meetings and staff meetings.
- The Town Hall is the 'Candy Store' during Candy Dance. Homemade candy is made for 2 months in advance and the housed and sold in the Town Hall during the 2-day event.
- Without a sound system, any type of speaking is difficult to hear, especially when there is a crowd gathered in the hall. We have an annual Christmas Concert and those in the back of the room cannot enjoy the music since there is no sound system to distribute the noise equally. Wedding and Memorial speeches go unheard by many throughout the room due to lack of a sound system. The ceiling is very high and rounded which makes for a beautiful room, however, it does not lend itself well to sound distribution.
