Comstock Historic District Commission Board Review of Current Regulations (revision 2005/2006)* Attachment to Agenda March 13, 2023

Objective

In 2005-2006, with public hearings, the CHDC reviewed the 1972 Regulations in order to streamline the process by which residents of the Virginia City National Landmark seek architectural project review. The goal was to move projects through the review and confirmation process more expeditiously. Those amended regulations have been in use since 2005-2006. In response to a recent Executive Order issued by the state governor's office, the CHDC will hold a follow-up review of the current regulations to explore any remaining opportunities for further streamlining and customizing to increase the boards' effectiveness.
