

**AMENDMENT TWO TO

(AGREEMENT)**

WHEREAS, the Agreement was executed on November 9, 2015; and

WHEREAS, Amendment One of the Agreement was executed on October 14, 2020; and

WHEREAS, the Bureau of Reclamation (Reclamation) requires additional time and funding resources to fulfill the Stipulations outlined within the Agreement; and

WHEREAS, Reclamation will send a copy of this executed amendment to the ACHP;

NOW, THEREFORE, in accordance with Stipulation VIII of the Agreement, Reclamation and the Nevada State Historic Preservation Officer (SHPO) agree to amend the Agreement as follows:

1. Amend Stipulation X so it reads as follows:

Unless terminated pursuant to Stipulation IX above, this MOA will be in effect until Reclamation, in consultation with the SHPO, determines that all of its terms have been satisfactorily fulfilled, not to exceed eleven (11) years from the execution of the MOA. At that time, this MOA will terminate and have no further force or effect. Reclamation will promptly provide the SHPO with written notice of its determination that all terms have been fulfilled and of termination of the MOA.
