Pursuant to Stipulations 17.2 and 16.1 the signatory parties have determined that it is beneficial to extend the expiration date of the 2019 Protocol from May 8, 2024, to May 8, 2026, to provide an additional two years to accommodate the current revisions occurring to the *Programmatic Agreement Among the Bureau of Land Management, the Advisory Council on Historic Preservation, and the National Conference of State Historic Preservation Officers Regarding the Manner in which the BLM will meet its Responsibilities under the National Historic Preservation Act* (nPA). This extension is necessary to ensure that the current Protocol does not lapse, and to ensure that the amendments to the nPA are addressed after completion.

Prior to May 8, 2024, California BLM, California State Historic Preservation Officer and Nevada State Historic Preservation Officer had agreed the Protocol was working well. This extension would not change Tribes or any other Consulting Parties' opportunities to consult. A two-year extension is necessary to prevent a lapse of the current Protocol.

All other language and stipulations in the 2019 Protocol are extended without modification and remain in effect until May 8, 2026.


