

**AMENDMENT #1 TO
PROGRAMMATIC AGREEMENT
AMONG

WHEREAS, the Agreement was executed on June 11, 2019, and in accordance with Stipulation XIII, C., the Agreement is set to expire June 11, 2024; and

WHEREAS, the Advisory Council on Historic Preservation (ACHP) approved an exempted category program alternative, “Exemption from Historic Preservation Review for General Services Administration Routine Operations and Maintenance” consistent with the provisions in 36 CFR 800.14(c) January 13, 2023; and

WHEREAS, in accordance with Stipulation XIII(C), GSA has contacted Signatories no later than 12 months prior to the expiration to request a one (1) year extension of the duration of the Agreement for GSA to conduct appropriate consultation with Signatories on substantive revisions to the Agreement reflecting provisions in the exempted category and allowing for additional review stipulations; and


NOW, THEREFORE, in accordance with Stipulation XIV of the Agreement the Signatories agree to amend the Agreement as follows:

1. Amend Stipulation XIII(C) from five (5) years to six (6) years (extending duration to June 11, 2025) so it reads as follows:
“The PA shall remain in effect for a period of six (6) years from the date of execution, or before terminated in accordance with the terms of this PA. No later than 12 months prior to expiration of the PA, GSA may initiate consultation to determine if the PA should be amended for an additional term, per Stipulation XIV.”

All other stipulations remain in full force and effect.




