#### AMENDMENT 1 TO

#### MEMORANDUM OF AGREEMENT

#### BETWEEN BUREAU OF LAND MANAGEMENT-

MT. LEWIS FIELD OFFICE,

#### THE NEVADA STATE HISTORIC PRESERVATION OFFICER,

**AND** 

#### MCCEWEN MINING INC.

#### REGARDING THE

#### GOLD BAR MINE PROJECT, EUREKA COUNTY, NEVADA

WHEREAS, the Memorandum of Agreement (MOA) was executed on November 1, 2017; and

WHEREAS, BLM, in consultation with the SHPO, has amended the Area of Potential Effects (APE) for the Mine to include an expansion to the existing Gold Bar Mine, referred to as Gold Bar South, located east of the previously defined APE. BLM has determined that the amended direct APE includes the Gold Bar Mine and Gold Bar South, totaling 5,528 acres, as well as the 1.4-acre parking lot in northern Eureka, NV, while the amended indirect APE is a variable boundary extending up to 7 miles from the direct APE (Attachment A1, Amended); and

WHEREAS, BLM, in consultation with the SHPO, has determined that forty (40) historic properties and unevaluated resources in the amended direct and indirect APEs have the potential to be adversely affected by the Mine (Attachment B, Amended); and

WHEREAS, BLM, in consultation with the SHPO, has previously undertaken activities to mitigate or partially mitigate adverse effects to twenty-two (22) of these historic properties and unevaluated resources (see Attachment B, Amended); and

WHEREAS, BLM, in consultation with the SHPO, has determined that the remaining eighteen (18) historic properties and unevaluated resources will be mitigated under a revised Historic Properties Treatment Plan (Attachment E); and

WHEREAS, BLM has consulted with the Te-Moak Tribe of Western Shoshone, the Battle Mountain Band of the Te-Moak Tribe of Western Shoshone, the Ely Shoshone Tribe, the Duckwater Shoshone Tribe, the South Fork Band of Western Shoshone, and the Yomba Shoshone Tribe, concerning the Mine, and has invited all six Bands or Tribes (hereinafter collectively referred to as Tribes) to participate in the MOA as Concurring Parties; and

WHEREAS, the BLM, in consultation with SHPO, has determined that the requirements of the MOA cannot be fulfilled prior to the expiration of the MOA on November 1, 2022 and that an additional five (5) years will be necessary to complete the stipulations of the MOA; and

WHEREAS, BLM, the SHPO, MMI, and the Tribes, agree that this MOA may be signed in counterparts and the executed MOA, and each signature, will be effective and binding; and

NOW THEREFORE, in accordance with Stipulation IX, BLM and the SHPO agree to amend the MOA as follows:

- 1. Amend Stipulation I.A. so it reads as follows:
  - A. Preparation of Attachment D (HPTP #1): MMI, through a cultural resource management (CRM) firm meeting BLM's and the Secretary of the Interior's Professional Qualifications standards, will prepare an HPTP (identified hereinafter as HPTP #1). This document will be consistent with the Secretary of the Interior's Standards and Guidelines for Archaeology and Historic Preservation (48 CFR 44716-37), the guidance provided in the ACHP's Section 106 Archaeology Guidance (www.achp.gov/archguide) (2009), and the documentation requirements of Appendix F of the State Protocol Agreement between the Bureau of Land Management, Nevada and the Nevada State Historic Preservation Officer for Implementing the National Historic Preservation Act (December 2014) (State Protocol) as appropriate. The HPTP will contain testing plans for the unevaluated resources and a mitigation strategy for all historic properties. BLM is considering the unevaluated resources to be eligible until an eligibility determination can be made by BLM, with SHPO concurrence, in accordance with the testing plans described in the HPTP. If the unevaluated sites are found to be eligible, then the HPTP Will be amended, as needed, to include mitigation strategies for those unevaluated sites determined to be historic properties.

#### 2. Amend Stipulation I.H as follows:

- H. BLM, in consultation with the SHPO, approved a revised HPTP titled A Plan to Treat Adverse Effects to Historic Properties Resulting from the Gold Bar South Expansion (identified hereinafter as HPTP#2) on June 4, 2021. HPTP #2 is Attachment E to this MOA.
- 3. Renumber Stipulation I.H as I.J and amend as follows:
  - J. If BLM determines, in consultation with the SHPO, that some of the unevaluated sites are eligible for the National Register of Historic Places, the Parties will amend HPTP #1 and/or HPTP #2, as needed, to include mitigation strategies for any historic property adversely affected by the Mine not previously addressed in HPTP #1 and/or HPTP #2.
    - 1. The Parties review of any amendments will occur in the same manner as HPTP #1 (Stipulation I.B through Stipulation I.F above)
    - 2. Amendments to Attachment D and/or Attachment E will not require a formal amendment to the MOA per Stipulation IX below.

- 4. Amend Stipulation II.B.4 as follows:
  - 4. The SHPO will review the summary within five (5) working days of receipt. If the SHPO does not respond within five (5) working days, BLM may issue the NTP to MMI for work within the avoidance area.
- 5. Amend Stipulation III so it reads as follows:

This MOA will expire when the stipulations are completed or five (5) years from the date of execution of Amendment 1 to the MOA, whichever comes first. BLM may consult with all Parties prior to expiration in order to re-examine the terms of the MOA and its amendments, determine if those terms are acceptable, and renew the MOA for another period of time not to exceed five (5) years.

If any historic property remains unmitigated at the time of expiration, and work is planned to continue on the Mine that would adversely affect any historic properties, BLM shall either (a) execute a new MOA pursuant to 36 CFR § 800.6, or (b) request, take into account, and respond to comments of the ACHP under 36 CFR § 800.7. Prior to such time, BLM may consult with the other Parties to reconsider the terms of the MOA and amend it in accordance with Stipulation IX below. BLM shall notify the parties as to the course of action it will pursue.

- 6. Delete Stipulation VIII.
- 7. Add new Stipulation XI.
  - XI. Change of Ownership: In the event that the ownership of the Mine changes during the implementation of this MOA, BLM will provide written notice to the SHPO regarding such a change in ownership. BLM will require the new owner to meet all the terms of this MOA as if it was the owner of the Mine at the time of the original execution of this MOA. The new owner will be deemed to be an Invited Signatory of the MOA.


