We are proposing to place a 20' Deep x 8' Wide x 8' Tall shipping container on the south east corner of our property. Our address is 166 South Q Street in Virginia City. Our property is uniquely situated in that the south/east corner of our property is essentially a "story" below the rest of our property (see attached picture). There is an existing shed located here and we keep our boat where the container would be placed. If you can envision the container where the boat is, that would be the location. The container would be placed length wise (east to west) into our embankment.


We are requesting the use of a shipping container due to its inherent ability not to rot like woodsheds would. There are retaining walls in place, however, we have sluffing of earth continually into the area in which we are requesting to place the container. The structural stability will allow the sluff off to continue without damaging the steel container. The back side and right side will not be seen by anyone, including any neighbors. The front and left side will only be viewable by our neighbor to the south. We have talked to Jayson, our neighbor, and he has no problem with this proposal.

We propose to put tin on the left side and front. There are two options available that look like old mining buildings. Pictures are attached. We would also be willing to put black tin siding instead of the bright tin color. The black may be less intrusive from direct sunlight. I am attaching copies of the black tin as well. This is the only thing that can be seen by our neighbor or anyone else.




